## JES Lecturer Biographies

**Karen Adams** is currently the Ex. Director of Inter-Church Ministries of Erie County and a VNA Hospice Chaplain after retiring from a career as a church music/ liturgy director and pastoral minister. She has been a NODA (No One Dies Alone) volunteer in Cleveland, Roanoke, VA and now at UPMC Hamot and was a hospice volunteer and doula in Roanoke prior to her return to Erie in 2019. She has been a strong proponent of hospice for 35+ years since both of her parents were in hospice care in rural upstate NY. Karen is also a member of the Board of Advisors for Julia Hospice and Palliative Care and believes that there is much education needed about the practices of palliative medicine and hospice care.

**Richard Arthur, M.A.**, is a native of Pittsburgh who has a lifelong interest in American Colonial History. A retired Army officer and adult educator, he currently is serving as Chairman of the Washington Statue Centennial and Rededication Committee that is preserving the statue of 21-year-old Washington on his first public mission to Fort LeBoeuf in present-day Erie County. He and his wife Mary Lou operate Winter's End, a bird, bee, and butterfly habitat in rural Erie County.

**John L. Barnett MSN, CRNP** graduated from Edinboro College in 2004 with his bachelor's degree and from Clarion University in 2010. John has been employed in many different specialties including Gastroenterology, Interventional Pain Management and Family Practice. He has worked in Palliative Care in both the inpatient and outpatient settings throughout his career. His interest in end-of-life care and hospice was fostered by his time working as a Registered Nurse in the MICU. During this time, he came to understand that patients and families often need specialized guidance when making decisions and clarifying goals of care. A native of Erie, Pennsylvania John and his husband of 22 years enjoy spending time with friends and family, raising organic vegetables and playing with their Yorkshire Terrier, Boo-Boo.

**Mary Bula, M.A.**, has led Erie Together, a countywide collective impact movement to make the Erie region a community of opportunity where everyone can learn, work and thrive, since April 2012. Before joining Erie Together, Mary was vice president of the Growth Partnership Division of the Erie Regional Chamber and Growth Partnership (ERCGP). Mary serves on a number of education and youth-related boards and committees. She holds a Bachelor's degree from Allegheny College and a Master's degree from the University of Pittsburgh Graduate School of Public and International Affairs.

**Pat Cuneo, B.S.**, serves as the Director of Publications at the Jefferson. He is a former reporter, editor, and columnist for the Erie Times-News. An Erie native, he is a graduate of the University of Notre Dame and studied journalism at Poynter Institute and the American Press Institute. Pat is the Editor of the Journal of Erie Studies and taught journalism at Edinboro University, Gannon University, and the former Alliance College. He is a board member of the Boys and Girls Club of Erie and a member of the Planning Board of the Town of Mina, N.Y.

**Sabina Shields Freeman, B.A.**, holds degree in Journalism from The Ohio State University. Freeman currently has several books in print about people and places in the Erie area. Her first book was about Erie city and county women, Erie History the Women's Story, which she co-authored with Margaret Tenpas in 1982 for the American Association of University Women (AAUW). Freeman's books are available through the Fairview Area Historical Society, the Erie County Historical Society, two local bookstores and her website: [hilightpress.com](http://hilightpress.com). Freeman has contributed articles to several historical magazines and is currently working on a comprehensive biography of Girard's circus showman Dan Rice.

**David Frew, Ph.D.**, a prolific author and historian, is an emeritus professor at Gannon University, where he held a variety of administrative positions during a 33-year career. He is also emeritus director of the Erie County Historical Society and is president of his own management consulting business. Frew has written or co-written 35 books and more than 100 articles, cases, and papers. He has authored or co-authored 40 books, most recently "Accidental Paradise: A 13,000-Year History of Presque Isle," and more than 100 articles, cases, and papers. His work has appeared in publications ranging from refereed journals such as The Journal of Applied Psychology to popular magazines such as Sail Magazine and Cruising World. Growing up on Erie's lower west side as a proud Bay Rat, Dr. Frew was known to join neighborhood kids playing and marauding along the west bayfront. He has written for years about his beloved Presque Isle and his adventures on the Great Lakes. In the "On the Waterfront Series" for the JES, the scholar-in-residence takes note of life in and around the water.

**Phil Friedman, Esq.**, is a partner at Conner Riley Friedman & Weichler based in Erie, Pennsylvania, Philip B. Friedman has a well-deserved reputation as a superior trial attorney. Representing clients throughout Pennsylvania, he focuses his practice on federal and state criminal defense and personal injury and wrongful death litigation. He is a fellow of the American College of Trial Lawyers and a former chairman of the Disciplinary Board of the Supreme Court of Pennsylvania. He is a past president of the Erie County Bar Association and a past member of the Board of Governors of the Pennsylvania Bar Association. Mr. Friedman attended Washington and Jefferson College and received a Bachelor of Arts Degree in political science in 1975. He received his legal education at the University of Pittsburgh School of Law and obtained his Juris Doctorate in 1978. Admitted to practice in both Pennsylvania and New York.

**Maria Goellner, Esq.**, is a public interest attorney and advocate for equal justice. She is the Pennsylvania State Policy Director for FAMM, a nonpartisan reform organization that strives to create a more fair and effective justice system that respects our American values of individual accountability and dignity while keeping our communities safe. Goellner is a graduate of Fordham University and New York Law School and previously acted as the sole Assistant Federal Defender for the Western District of Pennsylvania's Erie Division. She also served as a defense attorney in Florida's 20th Judicial Circuit and clerked with the Legal Aid Society in Queens before joining FAMM. She has protected the rights and dignity of thousands of families over the last decade. She has served on the Board of the Erie County Bar Association, co-founded its Diversity and Inclusion Division, and organized participatory defense and bail fund hubs. She also sat on the Third Circuit Lawyers Advisory Committee and has been recognized by the Pennsylvania Association of Criminal Defense Lawyers for exceptional advocacy and commitment to education and equal justice. She is a second-generation American and lives in Erie, Pennsylvania with her family.

**Deborah Gross, Esq.**, comes to Pennsylvanians for Modern Court from over 35 years of private legal practice in federal and state courts all over the country concentrating on complex commercial litigation. She was Chancellor of the Philadelphia Bar Association in 2017 and focused her efforts during the city's extraordinary legal nonprofit community. She spoke out on behalf of the Philadelphia Bar Association on the importance of judicial independence as the cornerstone of democracy and both received a commendation proclamation from the Mayor as a result of the work they did to train lawyers to assist lawful permanent residents in becoming naturalized citizens. Debbie also served as President of the Philadelphia Bar Foundation in 2013 and 2014, and as a Trustee of the Foundation from 2004-2020 and served on the Bar Foundation's Fundraising, Grants, and Finance Committees. She has served on the boards of many organizations such as Drexel's Kline School of Law, the Public Interest Law Center, Philly VIP, Temple Adath Israel of the Main Line, Women's Philanthropy of Jewish Federation. Debbie teaches at the Villanova University School of Law and received her J.D. from Boston University School of Law and her B.S. in Economics from the Wharton School of the University of Pennsylvania.

**Christopher Harben, D.S.L.**, teaches the capstone class for senior Business Majors at the Black School at Penn State Behrend. Dr. Harben also teaches International Business and is an adviser for International Business students, as well as the International Business Club. He is President of HLMC, LLC, a consulting/coaching firm specializing in small-business strategy, organizational behavior/design, and leadership development. Clients have included businesses in construction, manufacturing, professional services, retail, restaurants, and hospital systems. He designed and is the Coordinator of Fulton Leadership University—a nine-month leadership development program in Fulton County, Ohio. He holds a Certified Global Business Professional designation from the National Association of Small Business International Trade Educators.

**Kim Hill, M.A.** is an Erie native and has worked in the field of wellness her entire career. She is currently a mindfulness facilitator with over 40 years of teaching experience. Kim received her Training in Mindfulness Facilitation (TMF) certification from UCLA's Semel Institute for Neuroscience & Human Behavior in 2018 and has been an active certified member of the International Mindfulness Teachers Association since that time. She currently runs Mindfulness Strategies, a consulting firm that provides mindfulness training and programming to businesses, schools, universities, and other organizations. Prior to running Mindfulness Strategies, Kim taught health and physical education at the grade school, high school and college level. She received her undergraduate degree in Kinesiology from the Pennsylvania State University, her masters in Wellness for the University of Michigan and BSN in Nursing from Villa College. Currently Kim is a member of the National Ski Patrol and does volunteer work for Outdoor Emergency Response.

**Gary Horton, B.A.**, is the founder and CEO of the Urban Erie Community Development Corporation (UECDC) and the current President of the NAACP branch in Erie. Gary Horton is a passionate advocate for building vibrant communities by helping people to remove barriers to self-sufficiency. Horton is a co-founder of the Minority Community Investment Coalition as well as the neighborhood improvement group Eastside Grassroots Coalition. He also currently serves on the Erie Neighborhood Growth Partnership board and the Governor's Advisory Board for Environmental Justice. Since graduating from Cheyney University of Pennsylvania with a Bachelor's degree in Social and Behavioral Sciences and a minor in Political Science, Gary has given more than 30 years to public service. In addition to holding positions in the mayor's office, the governor's office and the federal Department of Health Education and Welfare, he also was elected to two terms as a School Board Director.

**Jackson Janes, Ph.D.**, is the President Emeritus of the American Institute for Contemporary German Studies at the Johns Hopkins University in Washington, DC, where he has been affiliated since 1989. Dr. Janes has been engaged in German-American affairs in numerous capacities over many years. He has studied and taught in German universities in Freiburg, Giessen and Tübingen. He was the Director of the German-American Institute in Tübingen (1977-1980) and then directed the European office of The German Marshall Fund of the United States in Bonn (1980-1985). Before joining AICGS, he served as Director of Program Development at the University Center for International Studies at the University of Pittsburgh (1986-1988). He was also Chair of the German Speaking Areas in Europe Program at the Foreign Service Institute in Washington, DC, from 1999-2000 and President of the International Association for the Study

of German Politics from 2005-2010. Dr. Janes is a member of the Council on Foreign Relations, the International Institute for Strategic Studies, and the Atlantic Council of the United States. He serves on the advisory boards of the Berlin office of the American Jewish Committee, *Beirat der Zeitschrift für Außen- und Sicherheitspolitik* (ZfAS), the Robert Bosch Foundation Alumni Association, and the American Bundestag Intern Network (ABIN) in Washington, DC. He is a member of the Board of the German American Fulbright Commission and serves on the Selection Committee for the Bundeskanzler Fellowships for the Alexander von Humboldt Foundation. He is a member of the Cosmos Club in Washington DC. Dr. Janes has lectured throughout Europe and the United States and has published extensively on issues dealing with Germany, German-American relations, and transatlantic affairs. In addition to regular commentary given to European and American news radio, he has appeared on CBS, CNN, C-SPAN, PBS, CBC, and is a frequent commentator on German television. Dr. Janes is listed in *Who's Who in America* and *Who's Who in Education*. In 2005, Dr. Janes was awarded the Officer's Cross of the Order of Merit of the Federal Republic of Germany, Germany's highest civilian award.

**Johnny Johnson, M.Ed.**, is a native of Covington, Georgia, and has been a resident of Erie for 45 years. Mr. Johnson taught health and physical education at various middle and high schools in Erie's Public Schools for more than 30 years before retiring. He coached many athletic teams and was the first African American to coach a varsity basketball team in Erie's history. He earned his master's degree in Curriculum and Administration in HPE from Slippery Rock University after earning his bachelor's degree in education from Fort Valley State University. He is one of the founding members of the Harry T. Burleigh Society, has participated in numerous historical programs, and is the author of *Erie African Americans in the 1880s*.

**Bruce A. Kibler, Ph.D.** attended the University of Maryland, College Park for a BS in Political Science and a MA in German Language and Literature, Johns Hopkins for an MAS in Business and Information Technology and Matej Bel University in the Slovak Republic for his PhD in Strategic and International Management. Dr. Kibler has performed projects in diverse countries such as the acquisition of Voicestream (T-Mobile) by Deutsche Telekom (\$53 bn) and the business transformation of Hrvatski Telekom, in Croatia. After a successful career in the business world Professor Kibler moved into academia and has championed community engagement via class projects uniting student learning, community involvement and economic development here in Erie, championing the alleviation of food deserts, fiber optic to the home, the creation of a land trust and much more. Professor Kibler has forged partnerships with international universities in Esslingen, Germany and Lublin, Poland, Erie's sister city. He has recently become more active in sustainability and economic development, specifically, engaging with Africa GreenTec to bring solar solutions to sub-Saharan African villages.

**Jaime Kinder, B.A.**, is the current Mayor of Meadville, PA. On January 3rd of this year, she was sworn in as Meadville's first woman and Black woman mayor. Jaime Kinder is a mother of three and lifelong resident of Meadville along with her mother, grandparents, and great grandparents. Jaime attended Edinboro University as an adult student and studied sociology and African American history. Jaime has worked in sales and management for most of her life, and she has a wide range of work experience, including cleaning services at Allegheny College, cashiering and factory work in Meadville. Currently, Kinder is the co-owner of Evolution Printing Systems, a custom printing and promotional product retail store that has been a part of the Meadville community since 2017. She has a Bachelor's degree in Sociology from Edinboro University.

**Katie Kretz, B.A.**, is the Executive Director of MCRC. Katie has been a resident of Erie since 2008. She was brought into the MCRC family in 2021 to help lead the organization into the future and to enhance services for the Latino, Refugee, Immigrant and New American population that MCRC serves. She brings a wealth of non-profit financial, managerial, organizational development and leadership skills to MCRC. Katie is a graduate of Averett University where she studied Business Administration and Equestrian Studies, and served twelve years with local human service agencies, providing services to children and adults with intellectual disabilities and autism. She participated in the Leadership Erie program of 2012 and served on the board of directors with Dr. Gertrude A. Barber Educational Institute. She is currently serving as a board member for Voices4Autism and is a member of the New American Council with the City of Erie.

**Rhonda Matthews, Ph.D.**, is an associate professor of political science and women's studies in the Department of Political Science and Criminal Justice at Edinboro University. Rhonda has been with the university since 2002 and served as the director of the Dr. Robert C. Weber Honors Program for three years. Prior to her work at Edinboro, she taught at several other institutions and worked in the fields of diversity affairs and residence life. Rhonda is dedicated to the advocacy and empowerment of women and children as a result of her previous work as a sexual assault survivor counselor. Using tenets of intersectional analysis, her primary areas of academic interest include gender & women's studies, sociological theory, popular culture and stratification. She is a long-time fan of science fiction, superheroes and comic books, is married and has one daughter.

**A Shared Heritage** is co-led by Johnny Johnson (Burleigh Legacy Alliance), Dr. Chris Magoc (Mercyhurst University), and Melinda Meyer (Erie Yesterday). Johnny Johnson, M.Ed., is a native of Covington, GA, and has been a resident of Erie for 50 years. Mr. Johnson taught health and physical education at various middle and high schools in Erie's Public Schools for more than 30 years before retiring. He is one of the founding members of the Harry T. Burleigh Society,



the current president of the Burleigh Legacy Alliance has participated in numerous historical programs and is the author of *Erie African Americans in the 1880s*. Dr. Chris Magoc is a professor of History at Mercyhurst University whose most recent book is *A Progressive History of American Democracy Since 1945: American Dreams, Hard Realities* (Routledge Press, January 2022). He is a 2012 recipient of the Mercyhurst Teaching Excellence Award. Melinda Meyer is an experienced public historian, educator, project consultant, grant writer and nonprofit administrator. As a public historian, she consistently pursues avenues to share local history with all audiences. Ms. Meyer has also taught museum studies and historic preservation undergraduate courses at Mercyhurst University.

**Pawel Paserbiak, Ph.D.**, is the head of the Department of World Economy and European Integration at the Institute of Economics and Finance, Maria Curie-Skłodowska University, Lublin, Poland. In his research, he focuses, firstly, on the phenomena and processes taking place in the global economy, with particular emphasis on the area of international trade and investment, and secondly, on the processes of regional economic integration, particularly in the area of Asia-Pacific. As part of the project SPEAC (Jean Monnet Network), with scientists from South Korea, Singapore, Germany, and Sweden, he is researching the phenomenon of connectivity between Europe and Asia. Also, under the Erasmus+ program, he cooperates with Gannon University, Erie, PA. Paserbiak is the author and co-author of numerous scientific papers, books, and book chapters. Professor Paserbiak lectured in numerous universities in Germany, Japan, Spain, and the United States.

**Phillip G. Payne, Ph.D.**, is a professor of history at St. Bonaventure University. He joined the faculty in 1998.
